This Scholarship Form is subject to the following criteria:

1. The applicant maintains a minimum cumulative GPA of 2.5. Note: if the minimum cumulative GPA falls below 2.5, the applicant must submit a written explanation for the drop in the GPA. However, there is no commitment on behalf of the Parker Fund Committee to renew the scholarship until the cumulative GPA meets the minimum standard.
2. The applicant submits this form with the requested materials below no later than May 15. **Note: Any information postmarked after May 15 will not be accepted.**
3. The applicant submits a letter stating:
  - a. What you have learned in college during the past year, and how this experience has made an impact on your life.
  - b. Why your scholarship should continue.
  - c. How your scholarship has impacted your education during the year.
  - d. Future plans and pursuits while in college.
  - e. Any significant changes in your educational goals.
  - f. Explanation of any Scouting related activities while you have been in college.
  - g. Any significant changes in your financial situation (i.e. financial hardship), if relevant.
4. The applicant submits a letter of recommendation from a college official (e.g. Dean, professor, or counselor).
5. The applicant must submit a college transcript for the year's final semester. If you have not received this transcript as of May 15<sup>th</sup>, please send the most recent transcript with your application, and a transcript for the year's final semester as soon as it is processed and received.
6. Yankee Clipper Council's Financial Aid Assessment Form.
7. The applicant provides a copy of the state/federal Financial Aid Form for the coming academic year and copies of any requests for additional sources of financial aid (e.g. FAF, civic groups, GSL)
8. The applicant submits a total of seven (7) sets (original and six copies) of this form and requested materials no later than May 15.
9. The applicant must be registered with the Boy Scouts of America either with a local unit or the "College Reserves."
